WHEREAS:

SOCA ITM U & Doc Systems desire collaboratively to deliver Data warehousing Training Programs provided by docsystems in the fields of Informatica (Data Warehouse & Data Mining) career development, career education, career skills training, and dissemination of career oriented knowledge on long term basis to SOCA ITM U students at SOCA ITM U locations, and also

Doc Systems has the capability, capacity, and interest to deliver Data warehousing (Infomatica) programs for use by SOCA students at SOCA ITM U facilities, and

SOCA ITM U has the capacity to provide necessary operations management in the form of buildings, educational facilities, equipment, materials, and supplies necessary to provide the delivery of DWH programs,

NOW THEREFORE in consideration of the mutual covenants and considerations contained herein, the parties hereto agree as follows:

Article 1 – SOCA ITM U Responsibilities

1.1 SOCA ITM U will be responsible for all costs associated with operations management in operating, maintaining, and managing educational facilities at SOCA ITM U locations including without limitation all **legitimate** SOCA ITM U expenses

1.2 Assisting students to attend Data Warehousing Training counseling and presentation sessions

1.3 SOCA ITM U will provide assistance to DOC SYSTEMS faculty and staff as appropriate in finding appropriate accommodation.

Article 2 -OPR Responsibilities

2.1 Provide curriculum and assessment tools for Data Warehousing (Infomatica-tool) Training. The contents and curriculum of this program will be decided in consultation with SOCA ITM U staff by and at the sole discretion of doc Systems All rights to the materials developed by or used by Doesystems in connection with the development and deployment of such programs, including without limitation, all intellectual property, and trademarks in all media now known, or hereinafter devised including the curriculum, teachers textbooks, or teaching aids, and all associated marketing tools and materials shall at all times remain the sole and exclusive property of docsys (docsys Proprietary Information), and shall not be reproduced without the express written permission of DocSystems However such proprietary information so developed for SOCA ITM U shall not be utilized by DocSystems for any other Client.

3.1 SOCA ITM U and Doc Systems agree that students interested in pursuing career programs shall be counseled on various options that would be in their best interest. The students who are interested to pursue such courses will be able to do so at SOCA ITM U campus.

3.2 The participating students will continue as students of SOCA ITM U, and will be enrolled as affiliate students in Doc Systems

Article 4: Fees Structure

4.1 SOCA ITM U would facilitate the Fees submission on behalf of the trainee students as and When invoice is generated.

4.2 It has been mutually decided that the fees of the Doc Systems would be as below plus service tax as applicable per student.

The payment shall be subject to attendance sheet(min of 25%) duly signed by the students and countersigned by the Doc Systems and SOCA ITM U representatives. The payment will be made on actual number of attendance.

Note : Provide Boarding/ Lodging facilities to the Instructor / Faculty members in accordance with the above programme up to 2 to 3 months

Article 5: Infrastructure & Modus Operandi

5.1 SOCA ITM U is required to provide classroom with LCD facility for the training.

5.2 IT Lab requires to have internet connection and the ratio will be one student per system.

5.3 Doc Systems will make available required course material for the training program

5.4 Both the parties are free to take their feedback on student's progress and trainer input, and suggest correctives

5.5 Doc Systems will responsible for development & installation of DWH lab.
